### 139th Annual Meeting Minutes

Sevier County Baptist Association -2024-

### Monday, October 21, 2024 | Session 1 Shiloh Baptist Church

- The opening video, "By Our Love" was played at the beginning of the meeting to point to the theme for the new year.
- Moderator, Edward King, welcomed everyone to the 139th Annual Meeting and encouraged everyone to look over the program for both sessions. Donny Hatfield led us in prayer as we began.
- The Shiloh Praise team led us in worship singing "10,000 Reasons" and "Mighty is the Power of the Cross".
- Moderator, Edward King, asked for a motion to seat the messengers & adopt the program. We received a motion, there was a second, so the motion passed. He also welcomed the guests and encouraged everyone to attend the Board meetings each month.
- AMS, Justin Johnson, came forward to recognize the new pastors that have joined since our last Annual Meeting. He also asked for prayer for the two churches without a pastor (Laurel Branch & Providence) & the three churches with interims (Alder Branch, Bethel, & Grace). He then shared his heart for the need for prayer for repentance, revival, cooperation, & encouragement among our churches. Pastor Glenn Metts led us in a prayer for repentance & revival.
- After the prayer, we watched a short video message from Randy Davis,
   President of the Tennessee Baptist Mission Board. Mark Miller, Discipleship
   Specialist with TBMB, came to share about the progress we've made in
   Tennessee with sharing the Gospel and seeing people baptized & set on the
   road to discipleship, but he also admonished us to continue sharing the Good
   News because Tennessee is still a harvest field any way you slice it. He also
   presented us with a plaque in recognition of Sevier County Baptist Association
   sending \$57,987 to Golden Offering for Tennessee Missions.
- To begin the business portion of our meeting, Moderator, Edward King, called

for nominations for the office of Moderator. Glenn Metts was nominated by Bill Stephens. A motion was made in favor of the nomination, there was a second, and the motion passed. Pastor Glenn Metts will serve as the Moderator after the 2024 Annual Meeting through 2026 Annual Meeting. Moderator, Edward King, then called for nominations for the office of Vice Moderator. Donny Hatfield was nominated by Justin Randolph. A motion was made in favor of the nomination, there was a second, and the motion passed. Donny Hatfield will serve as the Vice Moderator after the 2024 Annual Meeting through 2026 Annual Meeting.

- Moderator, Edward King, asked if there was any new business that needed to be brought before the assembly.
  - Bill Stephens, Constitution & Bylaws Committee Chair, came to present a proposed amendment to the Constitution & Bylaws (p.14-18) reflecting the changes necessary to reorganize the leadership structure of our organization. The Associational members must be notified of the change at least one day in advance before voting, so the vote will take place at Tuesday evening's session.
  - Justin Randolph, pastor at Zion Hill, made a motion to update the Proposed Budget. He asked that the Finance Committee meet to figure out how to add a line item for maintenance to the Block Party Trailer and report back at the next Annual Meeting with an updated Budget. He encouraged the Finance Committee to reconsider sending money to support local ministries that churches are already sponsoring and utilized those funds to support Associational efforts.
- Moderator, Edward King, asked for the ushers to come forward to take up the offering. Sully Smith & Macy Miller sang "Even If" during the offering.
- Justin Johnson, AMS, introduced Rick Curtis as the speaker for tonight's session.
   Rick Curtis serves as the Assistant to the President for Convention & Associational Relations at the North American Mission Board.
- Rick's message was titled "We Are Better Together" and he motivated us to start thinking differently in our churches to see a change in the community. His main points during the message were as follows:
  - We are one body with many parts
  - Unified efforts multiples evangelistic impact (Acts 2:46-47)
  - Kingdom collaboration glorifies God (Matthew 5:16, Ephesians 4:3-6)

• Justin Johnson, AMS, thanked everyone for coming & prayed over everyone. Shiloh's praise team led us in the song "Come Thou Fount of Every Blessing" as we closed out the first session.

### Tuesday, October 22, 2024 | Session 2 Henderson Chapel Baptist Church

- The opening video, "By Our Love" was played at the beginning of the meeting to point to the theme for the new year.
- Glenn Metts, Vice Moderator, called the meeting into order and led us in a word of prayer.
- Ellie Brooks & Deven Asbell led us in worship by singing "God is For Us" and "There is One Gospel".
- Glenn Metts, Vice Moderator, called the meeting to order and we moved on to unfinished business that was presented in the first session. A second was made for the motion to amend the Constitution & Bylaws as shown on p.14-18. There was no discussion on the matter. The vote was unanimously in favor of the amendment, so the motion passed.
- Glenn Metts, Vice Moderator, asked for any new business. Justin Johnson, AMS, came forward on behalf of the Finance Committee with a motion to approve the Proposed Budget for 2025 as shown in p.28. There was a second, no discussion, and all were in favor so the motion passed. Justin mentioned that the Administrative Team will be formed soon to make the requested changes from the motion made in the first session.
- Justin Johnson, AMS, reminded us of the special time we spent in prayer last night for repentance & revival. He talked about how crucial it was for us to also be cooperative with one another as the body of Christ and have an encouraging spirit among us. He then asked Linda Wilson, WMU Director, to come lead us in a prayer for cooperation & encouragement.
- There was a video announcement from Paul Chitwood at the International Mission Board, encouraging us to continue supporting missions through the

Cooperative Program and to continue reaching the nations together.

- Justin Johnson, AMS, gave a report on all the activities he's been involved with throughout the year from volunteering with local ministries to extending a helping hand to those in need throughout our community. He also shared briefly about the conferences & training he's been able to attend this year and made sure to let everyone know that we have resources available at the office that are free for the taking. He talked about how well things are going at Camp Smoky since we've brought on our new caretakers, Jonathan & Chasslene Bryant. He shared the vision the Camp Committee wanted to present tonight and then called upon Mrs. Robin Jones to share about Kids Camp coming back in 2025. She was so excited to make this announcement as it has been overwhelmingly accepted among the people she's been talking with about it. God is doing great things at Camp Smoky and excitement fills the air as we move forward with big dreams.
- Glenn Metts, Vice Moderator, asked for the ushers to come forward to take up the offering. Macy Miller & Justin Johnson sang "I Could Sing of Your Love Forever" during the offering.
- Justin Johnson, AMS, introduced pastor Ronnie White as the speaker for tonight's message. Pastor Ronnie has served at Paw Paw Hollow since 2011 and has served several years as Director of Missions for our Association.
- Pastor Ronnie White preached and encouraged us to remain faithful to sharing the Gospel with the lost & to remember that everyone needs Jesus.
- After pastor Ronnie's prayer, Ellie Brooks & Deven Asbell led us in a closing song of worship titled "What A Beautiful Name".
- Glenn Metts, Vice Moderator, shared from Psalm 133:1 & Matthew 28:19-20 as a challenge for us to continue in the spirit of unity & pray for each other as we leave from here. He asked for a motion to adjourn, there was a second, and all were in favor. The motion passed & the 139th Annual Meeting was officially closed.
- We had a total of 89 people attend, with 15 churches represented.

### PROPOSE CONSTITUTION & BYLAWS

### Article I - Name

This body shall be called the Sevier County Baptist Association.

### **Article II - Vision & Mission**

The vision for the Sevier County Baptist Association is to mobilize churches to strategically engage our community with the Gospel of Jesus Christ.

We will see this vision fulfilled by:

- Promoting fellowship & cooperation among our local churches, TBMB, & SBC.
- Fostering an atmosphere of genuine prayer
- Providing strategic resources/training through TBMB for discipleship that leads to a deeply rooted faith in God & His Word
- Sending Jesus-followers with the Gospel from our "Jerusalem" to the ends of the earth
- Encouraging churches to meet the physical, mental, & spiritual needs in our community

### Article III - Authority

This association is a self-determining body under the Lordship of Jesus Christ. It determines its own membership and programs, but has no authority over the churches affiliated with it. However; the association may, upon invitation from a church, collaborate with the church to meet their goals. It may also withdraw fellowship from a church considered by the Association to be out of harmony in doctrine or conduct. We affirm that marriage is recognized & accepted to be the union of one man and one woman in holy matrimony, regardless of any law or statement made opposing this – whether by local, state, national government, or Supreme Court ruling.

### Article IV - Membership

### A - Affiliation

A Southern Baptist church desiring affiliation with the Association will present its petition to the Executive Board accompanied by satisfactory evidence of doctoral regularity, proper constitution, and acceptable cooperation. Upon approval by the Executive Board, churches may be received into affiliation by a majority vote of the Annual Meeting.

### **B** - Messengers

Messengers from the churches shall constitute the Annual Meeting of the Association. Each church of the Association shall be entitled to two messengers for the first 50 members and one additional messenger for every 50 members, plus two

alternate messengers (not to exceed a total of 10 messengers including the pastor). Alternates are to attend and vote only in the event of the absence of the regular messengers. The pastor or interim pastor will automatically be a messenger.

### C - Disassociation

Should any church disqualify itself by practices or doctrines contrary to those of the Association, or fail to send an Annual Church Profile (henceforth ACP) and/or Messengers for three consecutive years, the Executive Board may, upon failing to reconcile such church, recommend disassociating with said church. A majority vote in the Annual Meeting will be required to withdraw fellowship from a church.

### Article V - Organization

### A - Officers

Officers of the Association shall be as follows: Associational Mission Strategist (AMS) - the role of the AMS is to first & foremost be a servant leader of the Association. Foundationally, the AMS must be called to Associational leadership, a person of character, spiritually mature, committed to learning, a leader of leaders, and trustworthy. Relationally, the AMS must be emotionally intelligent, an active listener, a supportive coach, authentically vulnerable, and a vocal encourager. Strategically, the AMS must be a vision caster, strategist, consultant, leadership multiplier, good communicator, and one with contextual understanding. The AMS may remain in office as long as the Association wishes for him to continue in this office or until he is called to leave. Moderator & Vice Moderator - Both the Moderator and Vice Moderator should be well-versed in parliamentary law and should be thoroughly familiar with the Bylaws and Constitution of the Association. The Moderator will conduct business at Executive Board meetings as well as the Annual Meeting. In the absence of the Moderator, the Vice Moderator will become the presiding officer. The duties of the Moderator include: opening the meetings at the appointed time by calling the meeting into order, having ascertained that a quorum is present; recognizing members who are entitled to the floor; stating and putting to vote all questions that legitimately come before the assembly as motions; protecting the assembly from obvious dilatory motions or disorder; expediting business in every way compatible with the rights of members; and declaring the meeting adjourned when the assembly so votes, at the time prescribed in the program, or at any time in the event of a sudden emergency affecting the safety of those present. The Moderator & Vice Moderator may serve two (2) years unless they wish to vacate their position early. Both positions will be elected at the Annual Meeting and will take office at the close of the Annual Meeting. Nominations may be made from the floor at the Annual Meeting and must have a majority vote to be elected. ☐ **Treasurer** - The treasurer of the Association is the officer entrusted with verifying financial records & keeping the Board informed of financial status throughout the year via Financial Reports & the Treasurer's Report at the Annual Meeting. He/She may be a signer on the Association's account. The Treasurer may serve multiple terms (if approved by the messengers at the Annual Meeting) but is only asked to serve for one (1) year. Clerk/Secretary - The Clerk/Secretary is the recording officer of the Association for Special-called, Executive Board, & Annual Meeting. The Clerk/Secretary may serve multiple terms (if approved by the messengers at the Annual Meeting) but is only asked to serve for one (1) year.

☐ <b>Men's Ministry Director</b> - Responsible for organizing events and projects throughout the year alongside the
AMS to encourage church cooperation & fellowship. The Men's Ministry director may serve multiple terms (if
approved by the messengers at the Annual Meeting) but is only asked to serve for one (1) year.
☐ <b>WMU Director</b> - Responsible for organizing meetings & projects throughout the year alongside the AMS to
encourage church cooperation & fellowship. The WMU Director may serve multiple terms (if approved by the
messengers at the Annual Meeting) but is only asked to serve for one (1) year.

### C - Associational Teams

Team members are asked to serve for at least one (1) year, but may serve multiple terms if approved by a majority vote at the Annual Meeting. Team Members may be asked to step down if they are not fulfilling their duties as active team members. Each team listed below will need to have an odd number of at least 5 members so that a decisive vote can take place if necessary.

Administrative (Stewardship, Personnel, Constitution/Bylaws, Recommendations/Nominations)
<b>Discipleship</b> (Small Groups, Prayer, Youth/Children, Contact for Supported Ministries)
<b>Ministry/Missions</b> (Ministry/Missions, Evangelism, WMU/Women on Mission, Men's Ministry, Disaster Relief)
Vision (Vision-Casting, Event Planning, Future Development)
Campus Ministry (Camp Smoky, Summer Camp, Campus Events)

A quorum shall be constituted when at least 60% of the Team is present. For any items that require a vote, with a quorum met, a majority vote will be sufficient to pass or deny said vote. Any recommendation from a Team will need to be brought before the Board at any scheduled Executive Board meeting and a representative of that Team shall be present to bring the recommendation.

### D - Executive Board

- The voting members of the Executive Board shall be composed of the pastor and two lay members from each church who are elected annually by the church. Officers and Associational Team Leaders shall also be voting members of the Executive Board.
- The Executive Board shall have authority to act for the Association between sessions, except as limited by this Constitution and any other limits so set by the Annual Meeting.
- 3) The Executive Board shall meet monthly on the last Monday of each month, with the following exceptions: the meeting in May shall be on the Monday preceding Memorial Day, October shall have no Executive Board meeting instead, the Associational Annual Meeting shall be held, and there shall be no Executive Board meeting in December. A Special-Called meeting shall require sufficient advance notice to all members from the AMS or Moderator stating the time, place, and purpose of the meeting. A quorum shall be constituted when five (5) Associational churches are represented in the Executive Board Meetings. A specific number of churches is not required for Special-Called Meetings.
- 4) An Executive Council shall be composed of the Officers & Associational Team Leaders. The Moderator shall serve as chairman and the Clerk as secretary. The Council shall meet prior to each Executive Board Meeting on

- the same day as the Executive Board Meeting. The Council shall not be required to meet prior to a Special-Called Meeting.
- 5) If the Moderator and Vice Moderator are absent from a scheduled meeting, a temporary Moderator may be nominated & elected to serve at the specific meeting.
- 6) If an officer position becomes vacant before the Annual Meeting, the Executive Board may nominate & elect, as needed, a person to fill the vacancy to complete the unexpired term.

### E - Trustees

A Board of Trustees, consisting of five members each elected for a three-year term, shall be nominated annually by the Administrative Team and elected by the Association at the Annual Meeting. The responsibilities of the Trustees include:

To hold in charge, for and in the name of the Association, the titles to all properties of the Association
To negotiate the transfer of title in case of purchases, or sale of real estate by the Association or its entities
To act under the direction of the Executive Board in relation to titles of property and securing of loans for the Association

### F - Facilities

The Sevier County Baptist Association adopts the policy that only member churches of the Association have access to the Association's properties and facilities, including, but not limited to the Association's office complex and Camp Smoky, for performing weddings, birthdays, and family reunions. The aforementioned properties and facilities, along with the Block Party Trailer and Disaster Relief Trailers, shall not be used for any activity that is not in agreement with our Biblical faith statement and beliefs as outlined in the Baptist Faith & Message 2000, the Association's Constitution & Bylaws, and the motion made & adopted by the Executive Board representatives at the September 28, 2015 Executive Board Meeting.

### **Article VI - Annual Meeting**

The Annual Meeting of this body shall be held on the third Monday & Tuesday evenings in October each year.

### **Article VII - Amendments**

This Constitution may be amended at any Associational Annual Meeting provided that at least one day's notice is given – as well as time for discussion – to any proposed amendment and that a majority of the messengers represented vote in favor of said amendment.

### **By-Laws**

The latest edition of Robert's Rule of Order shall be used as authority in deliberation. To uphold the doctrines of our Baptist faith as stated in the Baptist Faith and Message 2000.

### Carson-Newman University Associational Report 2025

Since Carson-Newman's founding in 1851, Tennessee Baptists have been instrumental in its creation, maintenance and growth. Your partnership and support enable us as Christian educators to help our students reach their full potential as educated citizens and worldwide servant-leaders. Highlights of this past year include:

- We welcomed students from 44 states and 55 countries for the 2024-25 academic year.
- At the start of the 2024-25 academic year, we launched the public phase of the largest comprehensive campaign in our history. Entitled "Legacy," the \$73 million phase of this initiative includes new academic programs, campus buildings and student recreation.
- C-N is already enjoying fruits grown out of the Legacy campaign. Last fall, we held two ribbon cuttings in one day, opening the 110,000 square-foot West Campus Commons residence hall and a new student Recreation Park, featuring: softball field, soccer pitch, and basketball, beach volleyball, pickleball courts. A new Child Development Lab opens this fall on the western perimeter of campus.
- The campaign has opened doors to new academic offerings: Master of Divinity, MBA in Entrepreneurial Leadership, Master of Accountancy and Business in Analytics. Degree programs in Homeland Security and Emergency Management, Artificial Intelligence in Business, and Hospitality and Tourism Management launched this fall. A Doctor of Nursing Anesthesia Practice launches Jan. 2026. Each offering is rigorous while being taught with a biblical worldview.
- Last fall we celebrated with 31 members of our Eagles football team who made public professions of faith by being baptized in Mossy Creek. This is the most we have ever had and demonstrates how the Spirit is moving on campus in mighty ways.
- For 2024-25, chapel on Tuesday and Thursday had an average attendance of 415 students (a 6% increase from the previous year.)
- C-N's Serve Day last year saw over 600 students take part in outreach at some 40 project sites across multiple counties. Students also packed 11,000 meals to be distributed to help feed those in need.
- In 2024, Appalachian Ministries of the Smokies (AMOS) celebrated 40 years of ministry. When the year had concluded, AMOS' Ministry Center had served 1,358 families and 3,339 individuals. The Home Repair Ministry completed 30 projects across four counties, while Samaritan House served 32 homeless families and provided 8,595 meals to those in need.
- Last year, C-N students shared the love of Jesus Christ through Spring Break mission trips to Los Angeles, Hawaii, Ecuador, Honduras, Southeast Asia, Alaska, Denver and Barcelona.
- This year U.S. News & World Report championed Carson-Newman's online programs. Carson-Newman and Vanderbilt University were the state's top private institutions in the Online Master's in Nursing Program category. In the Online Master's in Education Program category, only the University of Memphis was ranked higher than Carson-Newman in Tennessee. C-N was also named a "Christian College of Distinction" by Texas-based organization Colleges of Distinction.

### Tennessee Baptist Children's Homes

Tennessee Baptist Children's Homes has been welcoming children in hard places with the love of Christ for 134 years! Because of the faithfulness of churches, businesses and individuals who have a heart for children and families who are struggling, we have been able to serve over 237 children and their families over the past year. Thank you for your prayers, for your service, and for sharing your financial resources with TBCH. Our ministry operates without the use of government funds. We have chosen to rely on God's provision through His people to supply the resources necessary to meet the needs of the children and families we serve.

TBCH serves children through two programs. Our **Foster Care** program allows us to place children who are in the state's custody into homes where Jesus is loved and served and where children will have this godly influence in their lives for however long they reside in that home. Our foster care team and volunteers span from Memphis to Kingsport. The other program for providing gospel centered care is our **Residential Care** program. Our campuses in Brentwood, Chattanooga and Millington are all in the process of exciting changes related to our Firm Foundations Project. We are currently in construction mode on each of our three campuses to provide individual bedrooms and baths for each resident. Because of what many of our children have experienced or been exposed to, this need becomes more apparent as each year passes.

TBCH is making sacrifices to bring this "Firm Foundations Project" vision into reality. We are reducing the size of our campuses without reducing the number of children we serve. The liquidation of selected properties will help us complete Phase One of the Firm Foundations Project on each campus. While liquidated property is helping us put our plans into action we are still in great need of your financial assistance. Thank you to those of you whose church gives faithfully to the Cooperative Program and also makes a direct gift to TBCH through the Mother's Day Offering or through your annual missions offerings!

- 237 children served in the past year
- 19 adoptions in the last fiscal year and 14 so far this year
- 24 professions of faith in the last fiscal year and 6 so far this year- Praise the Lord!
- 70 foster homes statewide as of the writing of this report
- 127 children in care as of the writing of this report

Finally, please pray for us! Due to the severity of behaviors and the delay in families seeking help, connecting with the children we are equipped to serve has become a challenge across all three of our campuses. Would you join us in praying that the Lord would bring us into contact with the children and families we are best prepared to support? Thank you.

### Tennessee Baptist Adult Homes, Inc. Report to Associations, 2025

Tennessee Baptist Adult Homes now has a ministry in west Tennessee!! In March of this year, we moved our first residents into the first four duplex apartments at the new Baptist Village Humboldt! The apartments were filled within the first month of opening and there are others who would move in if we had more. We are so excited that this ministry is up and going. You may recall that there was the possibility that we might have to liquidate the Humboldt project due to the financial strains of our group home ministry. God has provided! It is our belief He will continue to do so. As funds allow, we will build more duplexes at Humboldt. When the entire Baptist Village Humboldt project is completed, there will be 10 duplexes serving 20 financially needy retired pastors and missionaries.

Regarding the financial issues mentioned above, we have downsized our group home ministry by closing one of the homes and reducing our resident capacity from 55 to 47. The downsizing has resulted in cost savings of around \$200,000. Our increased Father's Day Offering in 2024 coupled with the generous allocation increase or Cooperative Program funds (about \$117,000) are even more examples of God's provision! What an exciting time for the ministry of TBAH. We believe that 4 homes with a capacity of 47 is the right size for this ministry. We fell to as few as 43 residents earlier this year, but the current census is 45. I am so glad our homes are here for the families who have loved and cared for their family members and are no longer able to provide that care.

It is our hope and belief that this downsizing has made us "right sized" and that there will not be need for further downsizing. Our Father's Day Offering is one way, and our best way, to eliminate further cuts to our ministry. As of July 24<sup>th</sup>, receipts through the 2025 Father's Day Offering are about \$20,000 ahead of last year. You may recall that last year we set a record of \$547,000! This year's goal is \$575,000. If we can stay \$20,000 ahead of last year's giving, then we are knocking on the door of reaching our goal for a second year in a row. Again, exciting times.

At Union University, our vital partnership with Tennessee Baptists continues to shape our mission. As we reflect on the past year, we are reminded that our work is anchored in these core values: Excellence-Driven, Christ-Centered, People-Focused, and Future-Directed.

Consistent with the Tennessee Baptist Mission Board's strategic priorities—
strengthening and multiplying Gospel leaders, evangelistic disciples, and
healthy churches — Union has worked intentionally to connect students with
ministry opportunities:

- N N E S S & W
- The first TBMB ministry pipeline internship has been developed by Josh Franks in partnership with Union and area pastors. Beginning in the spring of 2026, students will serve in local churches, earn academic credit, and receive support from the TBMB, which plans to replicate this model across the state.
- At the request of TBMB, Union developed and taught its first class on church planting this past spring. Twenty-one students participated.
- Union hosted its second ministry fair this year, connecting students with local churches and ministries for internships and summer service.

### Selected Highlights from the Past Year

- In March, we opened and dedicated **The Ethos Forum**, a new academic facility for the McAfee School of Business and our computer science and engineering programs.
- Our comprehensive fundraising campaign, "Union 200: Tradition. Truth. Transformation." is progressing, with just over \$52 million given and pledged toward the \$80 million goal. Our next major project is a new chapel at the heart of campus a space for worship, training, and sending out Gospel leaders.
- In April, our trustees adopted a university **Framework for Biblical Anthropology**, developed by Union faculty to articulate a biblical view of humanity. The full version is available at <a href="https://www.uu.edu/about/framework-for-biblical-anthropology.cfm">www.uu.edu/about/framework-for-biblical-anthropology.cfm</a>.
- In March, hundreds of volunteers at Union participated in a six-day public reading of the entire Bible under Miller Tower as part of the 2025 Spring Bible Conference. As Isaiah 40:8 reminds us: "The grass withers, the flower fades, but the word of our God will stand forever."
- Union women's basketball coach Mark Campbell, who leads with Christ-centered excellence, was inducted into the Women's Basketball Hall of Fame in June.

Thank you for your investment in Union University in so many ways. We could not fulfill our mission and make a profound difference in the lives of so many young people without your support.

### Baptist Memorial Health Care System Memphis, Tennessee Jason Little, President and CEO

Baptist Memorial Health Care began as a 150-bed hospital in downtown Memphis in 1912. It was formed by the Southern Baptist Conventions of Tennessee, Mississippi and Arkansas because they recognized a tremendous need for a health care facility in this part of the country. The hospital eventually grew to become the largest private hospital in the world.

The Baptist Memorial Health Care system was created in 1981 to provide an integrated health care delivery system offering a full continuum of care to communities throughout the Mid-South. Today, a total of 24 hospitals in Arkansas, Tennessee and Mississippi; an 1,100-member physician group; and dozens of other entities are affiliated with Baptist.

Baptist Memorial Health Care's staff chaplains are a part of the health care team. Patients, family members and employees know they can ask for a chaplain at any time to augment our health care with spiritual or emotional care.

For the past eight years, Baptist's Pastoral Care Department has hosted The Rev. Jimmy Terry Preaching Series. The series, named in memory of a beloved member of Baptist's Board of Trustees and the founder of Tabernacle Baptist Church in Clarksville, Tennessee, welcomes a speaker each month to deliver an evangelical message from Baptist's flagship hospital. Video recordings of each event are posted on our Facebook page. They have been viewed more than 182,000 times and have reached 124,000 people in the past year.

Baptist Memorial Health Care received state approval to build a new community hospital in Fayette County. The facility will serve West Tennessee along the I-40 corridor between Arlington and Jackson, near BlueOval City, Ford's automotive manufacturing ecosystem. The hospital will include eight emergency rooms, eight acute care inpatient beds, outpatient imaging and lab services.

The Centers for Medicare and Medicaid Services awarded Baptist Carroll County, Baptist Tipton and Baptist Union City four stars (out of five) for quality. The ratings are based on 46 quality measurements from five categories: mortality, safety of care, readmission, patient experience, and timely and effective care.

Baptist Carroll County and Baptist Union City earned "A" Leapfrog Hospital Safety Grades in fall 2024 and spring 2025. Baptist Carroll County has earned five consecutive "A" grades, and Baptist Union City earned four consecutive "A" grades.

Several Baptist Memorial Hospitals earned Tennessee Hospital Association Zero Harm Awards for their infection prevention achievements. Baptist Carroll County and Baptist Tipton were two of only eight hospitals in the state to be recognized for zero harm events in four categories. THA also recognized Baptist Collierville, Baptist Women's Hospital, Baptist Memphis and Baptist Union City for not having infections in specific departments.

### 2025 Annual Report to Associations

The Tennessee Baptist Foundation has been serving TN Baptist with excellence since 1938. The assets under management of the Foundation have grown from \$6,577 to \$213 million during that time. God continues to bless this ministry, and we are pleased to make our report to the associations as to highlights for the fiscal year 2024-25 thus far. The Foundation is pleased to offer the following services to Tennessee Baptists:

- ♦ Faith-based estate planning seminars for churches and ministries
- ♦ Working with individuals, helping them develop distinctively Christian personal estate plans (wills)
- ♦ Assisting individuals in their establishment of various Charitable Trusts
- ♦ Serving as Trustee of trusts and funds committed to its care
- ♦ Providing investment services to Tennessee Baptist churches, associations and institutions
- ♦ Helping churches establish Legacy Ministries and create Endowment Funds
- ♦ Providing grants for qualifying new ministries and projects

Highlights of the Foundation's stewardship thus far for this fiscal year include (as of June 30, 2025):

- ✓ Client Accounts: 1,181
- ✓ Assets under management: \$213,000,000
- ✓ New accounts and additions: \$10,280,000 (22 new accounts)
- ✓ Educational scholarships: 200+ totaling \$225,000+ for 2025-2026 academic year. (Awarded almost \$7 million in scholarships since 1987)
- ✓ Special Project Grants: we have distributed \$46,200 to assist 7 ministry projects.
- ✓ Cooperative Program: \$344,000 distributed. Projected to give over \$500,000 by October 31
- ✓ Baptist and charitable causes: \$2,700,000 distributed. Projected to give over \$3.75 million by October 31
- ✓ Endowment Portfolio has averaged over 12% for the past 5 years

The *Baptist and Reflector* (*B&R*) is 190 years old this year, making it one of the 25 oldest, continuously published newspapers in the United States. Since 1835, the *B&R* has produced news features, and editorials that tell the story of Tennessee Baptists while also informing their biblical worldview.

The B&R is an award-winning newspaper frequently recognized by the Baptist Communicators Association for excellence in journalism, and is produced 26 times a year, reaching nearly 40,000 readers.

Additionally, the *B&R* website (BaptistandReflector.org) has grown steadily since it was introduced in late 2015, with more than 350,000 page views. The weekly e-newsletter has 21,000 subscribers and highlights breaking news, top stories from the print edition and news that appears in the online edition. The *Baptist and Reflector* continues to growth in our social media platforms such as Facebook, Instagram and X.

Over the past year, the B&R has extensively reported Tennessee Baptist Disaster Relief's efforts to help the people of East Tennessee recover from the devastating effects of Hurricane Helene. The paper has also offered frequent updates on Tennessee Baptist Mission Board's restructuring to bring it into alignment with the ministries Tennessee Baptists said they wanted to pursue through the Acts 2:17 Initiative. There was also a steady stream of great news stories focused on Tennessee Baptists and their churches ministering to their communities and sharing the Good News of Jesus Christ.

The *B&R* staff monitors, reports, and distributes the most pertinent stories related to the Southern Baptist Convention and cultural trends that could affect Tennessee Baptists.

The paper continually seeks new subscribers, either through individual subscriptions or through a multiple-subscription church rate plan. Every church needs a subscription and every church's leadership team, like pastors, ministers, deacons, Sunday School teachers, etc., need to stay informed about Baptist life in Tennessee.

### The King's Academy

Since 1880, Harrison-Chilhowee Baptist Academy has been serving East Tennessee and the world as a distinctively Christian school. For more than 30 years, Tennessee Baptists' accredited Christian boarding and day school has operated under the name of The King's Academy. Located in Seymour, TN, at the foothills of the Great Smoky Mountains, TKA continues to reach students locally and globally.

This past summer has been a season of transition, but God's provision and faithfulness have been evident at every step. Even through uncertainty, we have seen His hand clearly at work—raising up new leaders, opening doors for ministry, and reinforcing the truth that this school belongs to Him.

Here are some of the ways God has been at work at TKA this year:

- **Residence Life Program**: We anticipate serving 31 international students representing 17 countries. This diversity continues to enrich our Christ-centered, global community.
- Shen Science Center: After years of prayer and planning, construction has begun on the Shen Science Center. This facility will strengthen our academic program, particularly for students seeking STEM careers, and expand our reach among international families.
- Spiritual Life: Chapel Theme "Known": This year's chapel focus is built on John 10:14—"I am the good shepherd; I know my sheep and my sheep know me." In the fall, students will study the Gospel of John. In the spring, the life of David. Our goal is for every student to know they are seen, known, and loved by God.
- Education Freedom Scholarship: Over 100 students applied and enrolled at TKA through Tennessee's EFS program, reflecting both the need and the effectiveness of our outreach to local families
- **Library Renovation**: The school library received a full refresh with new carpet, paint, and a new Middle School Writing Lab. This space now better serves our growing student body.
- Campus Security Enhancements: All campus security cameras are in the process of being upgraded, and a new DVR system was installed to provide higher-quality footage. Student safety remains a priority.
- **Dual Enrollment Partnership**: TKA launched a new partnership with Carson-Newman University offering on-campus dual enrollment classes in College Algebra and Composition. This allows students to earn college credit in a Christ-centered learning environment with trusted faculty.
- Elementary Enrollment Growth: Several elementary grades now have waiting pools, reflecting strong interest from local families and continued enrollment momentum.
- **Projected Enrollment**: Based on current applications, enrollment is on pace to surpass our budgeted goal of 415 students, potentially reaching 430 this fall.

Through every challenge, God has reminded us that He is in control. We step into this school year with peace, not because we know the future, but because we trust the One who does.

Thank you for your continued support, encouragement, and prayers. We are honored to be part of the Tennessee Baptist family and remain committed to raising up students who live out their faith with courage and purpose.

### Tennessee Woman's Missionary Union 2025 Annual Report

Tennessee Woman's Missionary Union (TN WMU) encourages and equips churches and individuals to engage in missions learning and involvement that enables them to fulfill the Great Commission. This report shares information about some of the state events, ministries, and initiatives that have taken place.

Christian Job Corps (CJC) is a ministry of WMU that seeks to help men and women break the cycle of poverty through job and life skill classes, Bible study, and mentoring. There are 16 Tennessee CJC sites in 14 locations. In their 2025 annual ministry reports, these sites reported 784 participants in their various programs, nine decisions for Christ, and 417 volunteers serving 13,717 volunteer hours.

TN WMU's missionary care ministries are supported through funds from the Missions for Life Fund and the Golden Offering for Tennessee Missions (GOTM).

- Missionary Parents Fellowship (MPF): On September 28, 2024, 13 parents of International Mission Board (IMB) missionaries gathered via Zoom for a time of fellowship, information, prayer, and encouragement. TN WMU supports the Tennessee MPF by maintaining its database, distributing communication/promotion materials, and helping to coordinate and host the annual state retreat. The 2024 retreat was canceled due to flooding in Tennessee and was rescheduled as a Zoom meeting.
- Encourage Collegiate MKs: Each year TN WMU assigns a Missionary Kid (MK) who attends college in Tennessee to every association so churches can encourage them. Thirteen MKs were assigned to associations for the 2024-2025 school year.
- Former Missionary Fellowships: Former missionaries in West, Middle, and East TN gather several times each year for fellowship, connection, and encouragement. TN WMU provides funds for meals during these gatherings.
- Christmas Gifts: In December 2024, TN WMU sent gifts to missionary kids and retired missionaries. A \$150 gift was sent to 13 MKs whose parents serve with IMB and are from Tennessee, and a \$50 gift was sent to 69 retired IMB missionaries born in Tennessee.
- MK Re-Entry Retreat: Six missionary kids from Tennessee received travel assistance funds to attend the MK Re-Entry Retreat, hosted by Virginia WMU and the IMB, from July 28 to August 2, 2025.
- Missionary Homes in Mt. Juliet: Tennessee Baptist Mission Board has two missionary homes in Mt. Juliet that provide
  much-needed rest for missionaries on stateside assignment: the TN WMU Missionary House (Mary's House) and the
  Missions Mobilization Center (MMC) Missions House. TN WMU takes care of reservations and hosts the missionary
  families for both houses. Donated gift cards are used to stock pantry staples and other household items.



As part of the prayer advocacy partnership with Denver, TN WMU sent a mission team of six women to Denver from October 3-7, 2024. The team met with nine church planters and prayed for them, their ministries, families, and the communities around the churches. TN WMU has sent nine teams to serve in Denver over the past eight years, meeting with more than 30 church planters to pray and serve their communities.

The 2024 Connection was held at Tennessee Tech University's Baptist Collegiate Ministry on September 13–15, 2024, where 132 youth girls and leaders representing 15 churches attended. The event featured Bible study leader Leslie Hudson and IMB missionary speaker Angela Stoda.

RA Camp-o-Ree was held on October 18-20, 2024, at Linden Valley Baptist Conference Center with over 400 boys, leaders, and personnel in attendance. Boys participated in a multitude of activities, challenges, and crafts while enjoying the great outdoors, meeting missionaries, and attending two action-packed worship services. This missions camping event for boys in grades 1-12 is hosted by Mid-South Royal Ambassadors and TN WMU.

Over 60 people attended the WMU Gathering at Summit on Sunday, November 10, at Northside Baptist Church, Murfreesboro. TN WMU, Concord Baptist Association WMU, and Northside Baptist Church partnered together to host this time of fellowship and inspiration.

The 2025 Missions Get-Together was held at First Baptist Church, Dickson, on April 4 – 5, with a total attendance of 512 people representing over 130 churches. Participants attended four general sessions and five breakout sessions and connected with over 30 missions and ministry leaders. Participants donated over 9,000 items, \$60 in cash, and \$1,100 in gift cards for Pregnancy Resource Centers across the state through the event's ministry project. An additional \$13,005 was given through the event's missions offering, benefiting the Amy Hood Adoption Endowment (90%) and the TN WMU Tennessee N Touch Endowment (10%).

The 2025 TN WMU Annual Meeting occurred on April 5 during the Saturday morning general session of Missions Get-Together. The meeting included highlights of the work of TN WMU and the election of 2025–2026 state officers and new Executive Board Members.

TN WMU awarded \$36,600 in scholarships to 39 students attending graduate school, seminary, and undergraduate school in Tennessee for the 2025 – 2026 school year. These scholarships are funded through endowments, invested funds, and the GOTM.

In 2025, TN WMU collaborated with churches, associations, and other ministries to host over 15 adult and youth Mental Health First Aid (MHFA) training events across the state, as part of our emphasis on addressing the critical issue of mental health. MHFA is a skills-based training that teaches participants to identify, understand, and respond to mental health and substance use challenges.

The 2024 – 2025 Tennessee Missions Emphasis theme was "All Things Tennessee," with a GOTM goal of \$2,700,000. As of July 25, 2025, the total amount was \$2,462,461. The offering year goes from September 1 to August 31.
